## MSRT TECHNOLOGIST OF THE YEAR AWARD

Deadline Date: July 15th

### I. PURPOSE

Technologist of the Year is awarded to a technologist who has made contributions toward the growth of the society, commitment to the profession, outstanding service to the radiologic field at his/her place of employment, through the community and/or at the state or district level.

### II. QUALIFICATIONS

- A. The nominee must be a practicing Radiologic Technologist with a minimum of three years working in the field of Radiologic Technology (Nuclear Medicine, Radiography, Sonography, MRI, CT, or Radiation Therapy).
- B. Contributions and endeavors toward the growth of the profession, having exhibited commitment to the goals of the profession through personal involvement in some of the following areas:
  1. Community awareness (public relations, community involvement, civic groups, youth projects, volunteer public service organizations or education of the public).
  2. Participation in continuing education as instructor, or participant.
  3. Input and guidance in the affairs of the Society.
  4. Publication of papers or exhibits.
  5. Technical advancements.
- C. Must have exhibited outstanding service to the field of Radiologic Technology either at place of employment, the community, District, or State level.
- D. Hold membership in his/her professional Societies.

### III. GUIDELINES

- A. The nominator must submit a typed explanation why the nominee should receive this award.
  1. Through the combined effort of the nominator, Awards Chairman and the nominee's employer, the Awards Chairman will provide the judges of this award with the necessary information.
- B. The nominator must complete the application provided for the award.
- C. The application must include the following information:
  1. Full name of the nominee.
  2. Home address and phone number of the nominee.
  3. Date the nominee became a member of the Minnesota Society of Radiologic Technologists.
  4. MSRT District location nominee participates in.
  5. Name and address of the nominee's place of employment and name of nominee's supervisor.
- D. Name and address of the nominator and date nominator became a member of the Minnesota Society of Radiologic Technologists. **NOTE:** All nominators must be members of the Minnesota Society of Radiologic Technologists with the exception of Radiologists.

- E. Selection of the recipient of the award shall be the responsibility of the Awards Chairman, and two members of the Executive Board appointed by the President.
- F. The Award recipient's employer will be notified by the Awards Chairperson. Every effort should be made to have the recipient present at the Annual Meeting awards ceremony.

### IV. ADDITIONAL INFORMATION

- A. District Presidents are encouraged to solicit prospective Technologist of the Year nominations from district members.
- B. If the nominee qualifies for the MSRT Life Membership Award, this honor should be considered in lieu of the MSRT Technologist of the Year Award.
