## **MSRT STUDENT OF THE YEAR AWARD**

### **BACKGROUND**

The Minnesota Association of Radiography Students (MARS) Committee and the Executive Board of the MSRT present the "Student of the Year Award". This award was announced and established by the 1980-1981 Student Professional Affairs Committee and R.T. Advisors.

### **I. PURPOSE**

The purpose of this meritorious award is to give recognition to the Students of Radiologic Technology in Minnesota who have remarkably contributed to the profession of Radiologic Technology by participating in their professional Societies on a Region, State, or National level. This award is to serve as an incentive for all Students of Radiologic Technology to become interested and involved in professional societies.

### **II. QUALIFICATIONS**

- A. The nominee must be a student enrolled in an accredited School of Radiologic Technology in Minnesota. The nominee must have a minimum of eight (8) months of didactic and clinical education.
- B. The nominee must be a member of the Minnesota Society of Radiologic Technologists.
- C. The nominee must have exhibited outstanding service to the field of Radiologic Technology either at his/her educational institution (i.e. presented in services, taught classes, exhibited in Health Fairs, etc.) or in the professional Societies on a Region, State, or National level (i.e. held office, chaired a committee, was a committee member, presented essays or displayed exhibits at an annual meeting).
- D. The nominee may be nominated by any one of the following methods:
  1. The Educational Director of the nominee's institution.
  2. The Clinical Instructor of the nominee's institution.
  3. Any Registered Technologist on the staff of the nominee's educational institution. (i.e. Administrative Technologist, Chief or Supervising Technologist, Staff Technologist)
  4. The nominator cannot be a fellow student or a Registered Technologist who has any involvement in the selection process for the recipient of the award.
  5. The nominator must be a member of the Minnesota Society of Radiologic Technologists with the exception of Radiologists.

### **III. GUIDELINES**

- A. The nominator must submit a typed explanation stating why they feel the nominee is eligible for the award including the following information:
  1. A summary of the nominee's participation in the professional Societies.
  2. A summary of extra work done by the nominee at the educational institution (in-services, classes taught, tutoring, etc.)
  3. A summary of academic achievement.
  4. Character of nominee (attendance, dedication, patient interaction, etc.)

5. Community activity participation (church groups, volunteer work, scout leader, etc.)
- B. The nominator must complete the application provided for the award.
  - C. The application must include the following information:
    1. Full name of the nominee.
    2. Home address and phone number of the nominee.
    3. Name and address of the nominee's educational institution.
    4. Name of the nominee's Educational Director.
    5. Date the nominee entered training (month/day/year).
    6. Date the nominee became a member of the Minnesota Society of Radiologic Technologists.
    7. Name and address of the nominator and date nominator became a member of the Minnesota Society of Radiologic Technologists. **NOTE:** All nominators must be members of the Minnesota Society of Radiologic Technologists with the exception of Radiologists.
  - D. Selection of the recipient of this award shall be the responsibility of the MSRT Awards Committee, and the President of MSRT.
  - E. The Program Director of the recipient of the award will be notified 3 - 4 weeks in advance of the Annual Meeting so arrangements may be made for the recipient to attend the meeting.
  - F. The award will be presented during the MSRT Annual Meeting at the Awards Ceremony.
